Colleges-Private-Starting of a Private Degree College by Sri Chintalapati Bapiraju Dharma Samatha Chinanindrakolanu at Bhimavaram, West Godavari District-During 1972-73 - Orders - Issued.

From the Secretary Sri Chintalapati Bapiraju Dharma Samatha Letters dated 17-4-72 and 8-9-72.

ORDER:

Government permit the management of Sri Chintalapati Bapiraju Dharma Samatha Chinanindrakolanu to start a private Degree College at Bhimavaram, West Godavari District temporarily, for a period of one year, during 1972-73.

The permission accorded in para 1 above is subject to the following conditions:-

- A) The Management should run the college without any Government grant till such time as the Government are willing or Government are in a position to sanction grant-in-aid in any case not earlier than 5 years from the date of inception of the college and the question of admitting to aid may be considered in future, in any year, after 5 years when the Government are in a position to do so depending on the budget provision and other relevant factors.
- B) The Management should deposit Rs.25,000/- immediately and a further sum of Rs.25,000/- within six months from the date of opening of the college under the joint account of the Director of Higher Education and the chairman of the College Committee. The amount stipulated is in addition to the corpus fund to be deposited according to the instructions of the University concerned.
- c) The Management should fulfil all the conditions stipulated by the University in regard to accommodation, equipment, staff, play ground library etc., and it should have nothing in common with the existing Junior College.
- d) The College may collect tuition fees as decided by the Management.
- e) The Committee should allow fee concessions etc., to scheduled Castes and scheduled tribes and other Backward Classes as per the rules, in force, and the amount covered by such concessions will be reimbursed by the Government subject to the budget provision available in this regard, and according to the rules prescribed by the Government from time to time.
- f) The management should provide temporary accommodation to locate the college and provide pucca buildings, as early as possible and also to provide 30-50 acres of land for the college.
- g) The Management should take necessary action to obtain affiliation of the University concerned.
- h) The management should follow the rules issued by Government from time to time in regard to reservation for scheduled Castes, Scheduled Tribes and other Backward Classes in respect of admissions and the employment of staff.
- i) The college shall open with 1st year Degree Courses in B.A., and B.Com.

J) Telugu should be the medium of instruction
in the courses introduced.

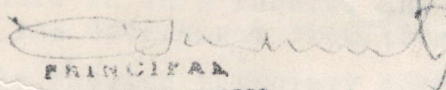
